PARTICIPATION NOTICE

Participation in the attractions of a trampoline park involves known and unforeseen risks that may result in death, paralysis, and/or physical and emotional injury to oneself and/or to others. Risks may include, among others, slipping, falling, colliding with an object and/or other persons, all of which may result in sprains, fractures, bumps, scrapes, bruises, dislocations, and injuries to any part of the body, including the head, back, extremities, and/or neck.

In consideration of my desire to participate in the activities and attractions provided by **Jumpalope Adventure Park** (the "Park"), I hereby RELEASE and DISCHARGE **Jumpalope Adventure Park**, **LLC**, a limited liability company organized in Puerto Rico, owner and operator of the park, as well as its members, shareholders, managers, directors, officers, agents, employees, volunteers, representatives, servants, predecessors, successors, assigns, affiliated entities, heirs, and/or franchisees from any accident occurring at the park, except for those arising from a dangerous condition that the park knew or should have known of, and which it had sufficient time to address and/or repair.

TERMS OF AGREEMENT

- (a) I accept that I and/or my children and/or persons under my care will use the park and its facilities in a safe and responsible manner.
- **(b)** I accept that I and/or my children and/or persons under my care will comply with the rules and guidelines of the park, as stated in the signage, videos, and/or instructions of the park's representatives, employees, and monitors. I acknowledge that:
- (i) these rules, instructions, and guidelines are meant to promote my safety as well as that of others.
- (ii) failure or refusal to follow said rules, instructions, and guidelines may result in our immediate expulsion from the park and its facilities, without the right to a refund of the admission ticket.

- (iii) the park's employees may provide us with limited emergency medical assistance, subject to my prior consent.
- (c) I fully and permanently agree to release and discharge Jumpalope Adventure Park from any and all claims, actions, demands, suits, and/or damages (including compensatory, general, special, consequential, exemplary, and punitive damages) of any nature, whether known at the time of my departure from the park or discovered later, arising from or in any way related to:
- (a) my activities, those of my children, and/or persons under my care within the park.
- (b) the activities of others within the park.
- (c) the operation of the park.
- (d) the use of the park's facilities; and
- (e) the use of the park's attractions, whether owned by me, Jumpalope Adventure Park, or third parties—except for those arising from a defect and/or unsafe condition in the park's facilities or attractions that the park knew or should have known of and had sufficient time to address and/or repair.
- (d) I agree to release, discharge, and indemnify Jumpalope Adventure Park from any and all losses, claims, costs, damages, and/or expenses of any kind, including but not limited to attorney's fees, costs, damages (direct or indirect), arising from or related to my acts or omissions, those of my children, and/or those of participants under my care while engaging in any activity in the park.
- (e) I accept and assume all risks involved in participating in the park and affirm that my participation, as well as that of my children and/or persons under my care, is entirely voluntary, and that the decision to participate in the park and/or bring minors is free and voluntary, with full knowledge of the existing risks.
- **(f)** I represent that I fully understand that participating in the park's activities involves physical effort, and therefore I represent that I, my children, and/or persons under my care:
- (i) are in good health to participate in activities within the park.
- (ii) have no pre-existing physical or medical conditions, including but not limited to pregnancy, back problems, heart problems, and/or respiratory issues, that could be affected or worsened by participation in the park; and
- (iii) will not use the park and its facilities under the influence of drugs, alcohol, or medications that may impair our physical abilities or judgment.
- **(g)** I certify that I have adequate insurance for myself, my children, and/or persons under my care to cover any injury or damage we may cause or suffer while participating in activities at the park. Alternatively, if no such insurance exists, I agree to personally cover the expenses for such injuries or damages.
- (h) I agree that any legal proceedings shall be brought in the Commonwealth of Puerto Rico and that the substantive and procedural laws of Puerto Rico shall apply to all such proceedings. I agree that if any portion of this agreement is declared null or illegal, the remaining portions shall remain in full force and effect.

(i) I authorize Jumpalope Adventure Park and its successors to capture and disclose my image, likeness, and sounds in photographs, video recordings, audio recordings, or other media ("images"), as well as those of my children and/or persons under my care, for an indefinite period. I acknowledge that Jumpalope Adventure Park shall be the owner of such images and I grant permission, without compensation, to Jumpalope Adventure Park or any affiliated entity of the brand, to record, display, publish, distribute, use, modify, and print such images in any lawful manner, including but not limited to publications, advertisements, brochures, websites, social media, and electronic displays and broadcasts thereof. The foregoing authorization shall not include the use of my name with any image unless otherwise agreed in writing. By signing this document, I acknowledge that I am waiving the right to bring legal proceedings against Jumpalope Adventure Park, both in my personal capacity, on behalf of my conjugal partnership, and on behalf of my children and/or minors under my care. I understand that I have had sufficient opportunity to read this document in full. I have read, understood, and agree to be bound by its terms. I further confirm that my waiver is voluntary, free, and without threats, coercion, or promises of incentives or guarantees in exchange.
